

Pontoon Boat Rental Agreement

SCOTTSDALE RANCH RESIDENTS ONLY

- ⇒ USAGE OF ANY OF THE SRCA FACILITIES AND PONTOON BOAT IS AVAILABLE ONLY TO RESIDENTS IN GOOD STANDING - RESIDENT SIGNING AGREEMENT MUST RESIDE IN SCOTTSDALE RANCH AT THE TIME OF THE PONTOON RIDE AND BE ON RIDE WITH GUESTS.
- ⇒ THE SIGNED PONTOON BOAT AGREEMENT AND A COPY OF THE RESIDENT'S HOMEOWNER'S INSURANCE DECLARATION PAGE IS REQUIRED. LEASE NOTIFICATION FORM AND RENTERS INSURANCE ARE REQUIRED FOR RENTERS.
- ⇒ Reservations must be made and require a 7-day minimum advance notice and are subject to staff availability.
- ⇒ Rides are available during the week and on the weekend from 10:00 a.m. to 9:00 p.m. based on staff availability.
- ⇒ A 1-Hour Complimentary Pontoon Ride is available once every 24 months per property 7 days a week from 10:00 a.m. to 9:00 p.m., but are NOT AVAILABLE between Thanksgiving Day and New Year's Day.
- ⇒ Pontoon Rental rates are as follows: \$35 for 1-hour and \$50 for 2 consecutive hours.
- ⇒ Holiday Boat rides to see the lights are \$30 for a 45 minute ride and are available Sunday -Thursday at 6:15 p.m., 7:15 p.m. and 8:15 p.m.
- ⇒ Residents may bring food and beverages onboard the pontoon boat.
- ⇒ Residents must start and end their ride at the dock located at the community center. We do not allow for any pick-ups or drop-offs at a resident's private dock.
- ⇒ At ALL times, cruises are governed by weather conditions such as wind, rain and lightning.
- ⇒ The boat accommodates up to 9 adults; a driver is provided by SRCA for liability reasons.
- ⇒ No pets are allowed.
- ⇒ A 72-hr. cancellation notice is required; otherwise, the complimentary ride is forfeited for the resident for the current 24-month period and any paid rental fees are also forfeited.
- ⇒ In case of after-hour emergency situations regarding this event, please call the 24-hr. answering service at 1-888-271-0019.
- ⇒ Gratuity is not required or expected.
