Order: Mike Breslin called the meeting to order at 4:35 p.m.

Minutes: **MOTION:** It was moved and seconded to accept the minutes of the June 05, 2024 Finance Committee meeting. Motion passed.

July 2024

Financial: Kathe Barnes gave an overview of the financial statements stating that SRCA remains in a strong financial position as we are over in revenue due to high interest rates on CD investments and under in expenses due to the monument signage project not yet being completed.

MOTION: It was moved and seconded to accept the July 2024 financial statement as presented and file for audit. Motion passed.

2025 Budget

Draft: The budget draft was presented, and Kathe Barnes reviewed each of the budget categories which included, Revenue, Landscape Maintenance, Lake Maintenance, Building Maintenance, Office, Administrative, Recreational and Communication with the committee members. Questions were answered.

Ms. Barnes finished the budget presentation by indicating that the 5-year budget forecast reflects no need to increase the annual assessment for the 2025 year. She recommended that the assessment remain at \$463.00 per unit in 2025 but that there may be a need for small increases in the coming years. The Finance Committee concurred and will revisit the annual assessment fees next year to determine if and how much of an increase may be needed.

MOTION: It was moved and seconded to present the 2025 budget draft to the Board as it is, and to recommend no assessment increase for the 2025 year.
Motion passed.

Delinquencies: Ricki Stamos reviewed the delinquencies to date and noted of the 3 accounts sent to the attorney for collections, one has already paid and delinquent accounts continue to remain low. More than half the liens filed this year have been released as payments have been made.
