Subm. #626351 – Garage addition, convert existing garage to storage – Unit 8

10295 E. Cochise Dr. – Meyer

MOTION: It was moved and seconded to ***disapprove*** the garage addition, and the conversion of the existing garage to storage due to the impact of the tall mass close to the front of the property with a small front yard footprint.

Subm. #626606 – New light fixtures– Sierra Linda

10583 E. Palomino Rd.– Giannetti

MOTION: It was moved and seconded to **approve** the light fixtures as submitted with the relocation of the house numbers. The house numbers will be relocated beneath the new fixture on the right side of the garage.

1 front entry fixture was installed.

2 - garage wall fixtures will be installed.

The front entry wall light fixture has been replaced.

The same style light fixtures are requested to be installed on each side of the overhead garage door on the top pop out.

Each 12.4" long x 6.1" deep wall sconce fixture has a vertical black rectangular frame with open frame sides and a vertical cylinder of glass in the center.

The automatic night sensor dusk to dawn 3000K integrated LED light fixtures are 10 LED watts, roughly 500 lumens each.

Subm. #626483 – Attached patio cover to rear of home– Sierra Linda

10587 E. Caron St. – Sheahan

MOTION: It was moved and seconded to **approve** the dark brown aluminum lattice patio cover with recessed lighting that will be attached to the back of the house.

The structure will be Alumawood dark bronze and be 50' long by 10 - 12' deep.

The roof will be open air slats.

The structure is 18.1' to the west property line and over 21' to the east property line.

It will be 31.4' from the back property line.

Subm. #623410 – Raise pony wall, gate, entry door, pavers – Sierra Linda

10559 E Palomino Rd. – Ose

MOTION: It was moved and seconded to **approve** the rustic iron powder coat new front door will be installed.

A new entry door will full glass and 3 clear vertical sections will be installed in the existing location.

MOTION: It was moved and seconded to **disapprove** the raised wall, gate, and pavers due to a concern of the wall's uninterrupted mass and existing details that will not be continued on the new wall area. The homeowner is invited to resubmit with some changes to address these concerns. The resubmittal can be reviewed on the staff level.
