**CALL TO ORDER:**

It was the consensus of the committee to recommend that the SRCA Board appoint Heather Miller to the Lake Committee.

**Sedimentation Study**

Kathe Barnes presented a proposal for a lake sedimentation study from Aquatic Consulting in the amount of \$4,835. This is for mapping the lake sediment and water depth for the entire lake. It also includes an option for a chemical characterization of the sediment that may assist in lake management decisions and sediment disposal options. The last study was done by Aquatic in 2019. This will assist also with the analysis of how the microbes are working.

**MOTION:** It was moved and seconded to approve the \$4,835 for Aquatic

Consulting to do the sedimentation study after the lake repairs are completed. Motion passed.

**Spring Fish Stocking**

Kathe Barnes reported the fish were stocked last month; however, the bass came in at only 2". They were supposed to be 4 – 6". SRCA will receive a credit for that cost.

The committee discussed the concerns with the lack of fish in the lake and the sizes. They felt a fish study is necessary to assist in knowing what is out there and if SRCA needs to increase the amount of fish and baitfish stocked. It was thought to look at the shock method for better accuracy.

Doug Kiley has talked to a hatchery on TX but they do not deliver to AZ. This hatchery has the hybrid bass. Kathe will see if there is a fish truck for hire to haul the fish. Also, he was going to look into potentially getting the warm water shad variety from the same hatchery.

Greg Mona will do research on whether the microbes could affect the fish population and report back to the committee.

**Concrete Lake Edge repair**

Kathe Barnes reported that the repairs will be done to the concrete edge of the lake the week of June 23<sup>rd</sup>. The lake will be low enough by then to make the repairs.
